I. Setting up a company requires the fulfillment of various formalities in order to establish all the legal aspects of the company

1. choosing a registered office/ headquarters
2. the company name
3. the constitutive act of the company
4. the social capital of the company, judicial fees
5. the formalities for registering the company at the Registry of Commerce
6. getting a tax identification code
7. certificates and legal authorizations for running a company



II. The registered office

- The first step in creating a new company is to establish the space where the company will have its main headquarters and, if necessary, choosing secondary headquarters.

The headquarters is in the club of Agriculture and Food Industry 'Vasile Adamachi' College Iasi and the alternative site can be a member home.



III. The name of the company

- Establishing the name of the new company and, if necessary, of its emblem:

The name of company is „Două Mâini Dibace” („Two skilled hands”)



IV. The constitutive act of the company

- the constitutive act is drafted according to company's legal form which is chosen by the associates with the legal advisory of an attorney, a notary. Associates can also ask for counseling at the Counselling Bureau of the designated Chamber of Commerce.



V. The social capital of the company, judicial fees

- the contributions in cash are deposited at the bank and the property documents for the contribution in kind are drafted

VI. Formalities at the Registry of Commerce

- the company's file with all the necessary documents is lodged at the Registry of Commerce located in the same county where the company's headquarters was set




VII. Obtaining the tax identification code

- fiscal registration of the company and obtaining the tax identification code from the territorial Financial Agency

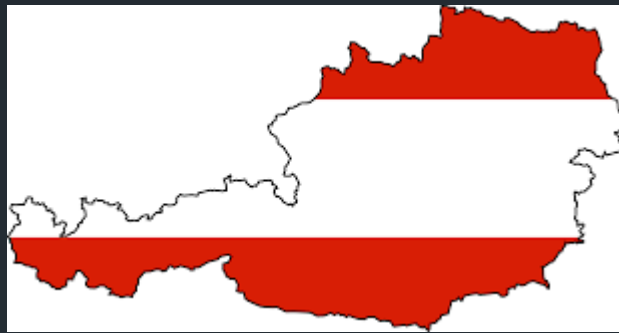
